**MEMORANDUM OF UNDERSTANDING
BETWEEN THE GOVERNING BOARD OF THE INTERLOCAL
DRUG TASK FORCE (WESTNET) AND THE PARTICIPATING AGENCIES**

WHEREAS, Kitsap County, Mason County, the City of Bainbridge Island, the City of Poulsbo, the City of Port Orchard, the City of Bremerton, the City of Shelton and the Washington State Patrol entered into an interlocal drug task force agreement in June of 2003 and amended December 8, 2003 (hereinafter "Agreement");

WHEREAS, the policy-making board of the interlocal drug task force ("Governing board") consists of the Chiefs of Police of the Cities of Bainbridge Island, Bremerton, Poulsbo, Port Orchard, and Shelton; the Sheriffs and Prosecutors of the Counties of Kitsap and Mason; and the Chief of the Washington State Patrol, or their respective designees;

WHEREAS, Kitsap County, the City of Bainbridge Island, the City of Poulsbo, the City of Port Orchard, the City of Bremerton, the City of Shelton and the Washington State Patrol currently assign a detective and/or supervisor to the task force;

WHEREAS, the Governing Board on February 20, 2004 approved a proposal offering financial support to the participating agencies;

WHEREAS, the Governing Board agreed to reimburse Kitsap County, the City of Bainbridge Island, the City of Poulsbo, the City of Port Orchard, the City of Bremerton, the City of Shelton and the Washington State Patrol for overtime wages up to \$10,000 for their assigned detective(s) and/or supervisor.


WHEREAS, the Governing Board, Kitsap County, Mason County, the City of Bainbridge Island, the City of Poulsbo, the City of Port Orchard, the City of Bremerton, the City of Shelton and the Washington State Patrol agree that this Memorandum of Understanding is subject to the terms and conditions of the Agreement; that this Memorandum of Understanding is contingent upon continued operation of the task force; that the Memorandum of Understanding may be terminated by any party upon thirty days written notice to each of the other parties; and that funding is subject to fund availability in the WestNET fund,

Now, therefore, the parties hereto, do agree as follows:

- (1) The Governing Board agrees to reimburse Kitsap County, the City of Bainbridge Island, the City of Poulsbo, the City of Port Orchard, the City of Bremerton, the City of Shelton and the Washington State Patrol for overtime wages up to \$10,000 for their assigned detective and/or supervisor.
- (2) The parties agree that this Memorandum of Understanding is subject to the terms and conditions of the Agreement, that this Memorandum of Understanding is contingent upon continued operation of the task force; that the Memorandum of Understanding may be terminated by any party upon thirty days written notice to each of the other parties; and that funding is subject to fund availability in the WestNET fund.




