	<b>f.</b> Surplus Properties	<p>Erickson gave an update on the sale of surplus properties. Booher discussed the possibilities of the proceeds. It is up to Council; however, the original intent was to back fill the debt payments. That is why the 2012 note we went out for we went with a five year call because originally we were suppose to sell the properties and not go out for that next round of debt. The police station was never in the original agreement, but it became part of it because of the devaluation of the City Hall property. Here is the question: we have a lot of things we are talking about going out to debt for, like the PW Yard, we need to evaluate whether we pay down the debt, which may not be as much savings as debt service cost for future projects. The Council needs to decide if they want to pay down the debt, or utilize it and not go out for future debt. On the 2009 debt, they just got much lower interest rates. She is continuing to monitor if it would be cheaper to borrow money or use the cash we have. We are not far enough into the design to look at the rates. It is a timing question. The city will also be doing revenue debt for the sewer, and engineering's CIP. The goal is to keep it under \$10MM per annum for the lowest rates.</p> <p>Discussion was held regarding risks the City is facing. Stern wants to understand the limits of the insurer's liability and where the City stands. He would like some time to pass before reallocating funds.</p>
