ORDINANCE NO. 2008-14

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REPEALING CHAPTER 9.09 OF THE POULSBO MUNICIPAL CODE REGARDING FIRE-RELATED CRIMES, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City of Poulsbo undertook a major update and reorganization of its criminal code in October 2007, and

WHEREAS, as part of Ordinance 2007-30, the City Council intended to repeal Chapter 9.09 of the Poulsbo Municipal Code regarding fire-related crimes, and

WHEREAS, due to an error, Ordinance 2007-30 did not repeal Chapter 9.09, and

WHEREAS, the Poulsbo City Council has decided to repeal Chapter 9.09. as previously intended, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

**Section 1.**     **Repeal of Chapter 9.09.** Chapter 9.09 of the Poulsbo Municipal Code titled, "Fire, Crimes Relating To," is hereby repealed.

**Section 2.**     **Effective Date.** This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.
