ORDINANCE NO. 2013-08(a)

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON RELATING TO THE MUNICIPAL STORMWATER UTILITY; REVISING CHAPTER 3.12 ENTITLED "FEES, COSTS, AND OTHER CHARGES", PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Chapter 3.12 of the Poulsbo Municipal Code establishes a schedule of stormwater charges for all utility customers, and

WHEREAS, the service rate schedule and fees must be designed to reflect the true cost of the delivery of service, and

WHEREAS, the existing charges do not reflect the true costs of providing service, and

WHEREAS, there is a need to adjust the rates to reflect the true cost of service,

NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Amend. Sections 3.12.100 entitled "Utilities-Schedule of assessments, rates, fees and charges for certain utility services is hereby amended to read as follows:

SECTION 3.12.100 Utilities – Schedule of assessments, rates, fees and charges for certain utility services

F. Service Rates—Stormwater. The following monthly stormwater service rates are established on or after August 1, 2013:

Single-family residential	\$10.57/month
All other accounts	\$10.57/billable ISU/month

6. Service Charges—Field. The fees for service calls to the served premises are established as follows:

Cross-Connection Control	\$50.00
Inspections	
Service Fee After Hours	\$75.00
Hydrant Installation	\$3,000.00
Hydrant Service Rate (Private Hydrant)	\$10.00/month
Inspection	\$36.00/inspection/ connection

Section 3. Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective Date. This ordinance shall take August 1, 2013.


