ORDINANCE NO. 2014-06

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING CHAPTERS 6.01, 9.02, 9.40, 9.70, AND 12.28 OF THE POULSBO MUNICIPAL CODE AND ADOPTING BY REFERENCE STATE LAWS ESTABLISHING VARIOUS MISDEMEANOR CRIMES AND INFRACTIONS; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Poulsbo desires to update Chapters 6.01, 9.02, 9.40, 9.70, and 12.28 of the Poulsbo Municipal Code to adopt by reference state laws establishing various misdemeanor crimes and offenses and infractions.


