ORDINANCE NO. 2015-15

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REPEALING SUBSECTION 12.28.160 OF THE POULSBO MUNICIPAL CODE THAT ESTABLISHED A PERMITTING PROCESS FOR MARINE REGATTAS AND RACES THAT HAS SINCE BEEN REPLACED BY THE SPECIAL EVENT PERMITTING PROCESS IN CHAPTER 5.04 OF THE POULSBO MUNICIPAL CODE; ESTABLISHING AN EFFECTIVE DATE AND PROVIDING FOR PUBLICATION BY SUMMARY.

WHEREAS, Ordinance 86-41 established a permitting procedure for regattas and races and vested the authority for issuing a permit in the chief of police, and

WHEREAS, Ordinance 2010-20 amended language in Chapter 5.04 of the Poulsbo Municipal Code regarding the definition of a special event which would include marine races and regattas, and

WHEREAS, the special event permitting process as codified in Chapter 5.04 involves review and input from all city departments potentially impacted by a special event rather than a single department, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Poulsbo Municipal Code Subsection 12.28.160 and the part of Ordinance 86-41 establishing Poulsbo Municipal Code Subsection 12.28.160 are hereby repealed.


Section 2. This ordinance shall take effect and be in full force five days after the date on which the attached summary consisting of the title will be published.


