**A RESOLUTION AUTHORIZING APPLICATION FOR FUNDING ASSISTANCE FOR A YOUTH ATHLETIC FACILITIES (YAF) PROGRAM PROJECT TO THE RECREATION AND CONSERVATION FUNDING BOARD (RCFB) AS PROVIDED IN CHAPTER 79A.25 RCW.**

**WHEREAS**, the City Council of the City of Poulsbo has approved a Comprehensive Park and Recreation Plan that includes these project areas; and


**WHEREAS**, under the provisions of YAF, state funding assistance is requested to aid in financing the cost of facility development; and

**WHEREAS**, the City Council of Poulsbo considers it in the best public interest to complete the development projects described in the application;

**NOW, THEREFORE, BE IT RESOLVED, THAT:**

1. The Mayor be authorized to make formal application to the RCFB for funding assistance;
2. Any fund assistance received be used for implementation of the project known as the Strawberry Multi Use Community Fields;
3. The City of Poulsbo hereby certifies that its share of project funding is committed and will be derived from a combination of appropriations and volunteer support through a partnership including the Kitsap Public Facilities District, the North Kitsap School District, Kitsap County, the North Kitsap Soccer Club, North Kitsap Soccer, North Kitsap Lacrosse, North Kitsap Cross Country, and Poulsbo Rotary Club.
4. We acknowledge that we are responsible for supporting all non-cash commitments to the sponsor share should they not materialize;
5. We acknowledge that any property developed with RCFB financial aid must be placed in use as an outdoor recreation facility and be retained in such use for a minimum of 20 years from final reimbursement unless otherwise provided and agreed to by our organization and the RCFB;
6. That this resolution become part of a formal application to the RCFB; and
7. We provided appropriate opportunity for public comment on this application;
