A RESOLUTION OF THE COUNCIL OF THE CITY OF POULSBO APPROVING THE INTERLOCAL AGREEMENT WITH THE ASSOCIATION OF WASHINGTON CITIES (AWC) RISK MANAGEMENT SERVICE AGENCY (RMSA) AND ITS MEMBERS

WHEREAS, the RMSA is a municipal self-insurance pool formed January 1, 1989, under RCW 48.62 to provide property and liability insurance coverage to participating members of the AWC; and

WHEREAS, the AWC RMSA offers coverage for its members to provide cost stability and the potential for long-term savings for the following property and liability coverage; and

WHEREAS, the RMSA is sponsored by the Association of Washington Cities as a service to Washington cities and towns; and

WHEREAS, the City of Poulsbo has reviewed the AWC RMSA Interlocal agreement with legal counsel for compliance with the Charter and Ordinances; or both, of the City of Poulsbo; and

WHEREAS, the City of Poulsbo has determined that the Interlocal Agreement would be beneficial in managing the municipal risks involved in providing services to its citizens;

NOW, THEREFORE, the City of Poulsbo does hereby agree to enter into and abide by the Interlocal Agreement, which constitutes a contract between the City of Poulsbo and the AWC RMSA. The Interlocal Agreement will become effective in 2010.
