

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, REJECTING ALL BIDS RECEIVED BY THE CITY ON THE MODIFY CITY HALL FOR POLICE DEPARTMENT RELOCATION PROJECT NO. CN2011-003.

WHEREAS, the City of Poulsbo recently opened bids on the Modify City Hall for Police Department Relocation Project No. CN2011-003 ("the Project"), and

WHEREAS, the City utilized Builder's Exchange to distribute Contract Documents to potential Bidders, and

WHEREAS, Builder's Exchange failed to post Addendum No. 2 to the Bid Documents in a timely manner for all potential Bidders to receive the information, and

WHEREAS, two Bidders failed to acknowledge Addendum No. 2 in their bids resulting in the receipt of two protests of the bid process, and

WHEREAS, the City has the authority to reject any and all bids pursuant to RCW 35.23.352 and has determined this is the best course of action to maintain fairness in the bidding process, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVE AS FOLLOWS:


