### 2. COMMENTS FROM CITIZENS

- **a.** Rita Hagwell commented on Marelaine Lane and whether she lives on Viking Avenue, Viking Way, or Marelaine Lane.
- **b.** Caroline Stein announced the Washington State Science & Engineering Fair will be in Bremerton this weekend at Bremerton High School and invited the public to attend.
- **c.** Mike Regis spoke to the February 2014 Kitsap Business Journal article reporting on an Attorney General opinion regarding banning marijuana businesses

# 3. MAYOR'S REPORT AND COUNCIL COMMENTS

- **a.** Councilmember Lord commented on the blooming daffodils and the new street lighting on Highway 305.
- **b.** Councilmember Musgrove also commented on the daffodils and holiday decorations; and stated he has also been visiting city parks, commenting how great they look.

# a. Resolution No. 2014-02 Authorizing Investment in the State Local Government Investment Pool

Finance Director Booher explained in an effort to provide more clarity with respect to how the State Local Government Investment Pool (LGIP) operates, the State Treasurer's Office has created a prospectus. They require all participating agencies to complete an updated resolution acknowledging the government body responsible for oversight has read and understand this prospectus.

**Motion:** Move to adopt Resolution No. 2014-02, a resolution authorizing investment of City of Poulsbo monist in the Local Government Investment Pool.

Action: Approve, Moved by Berry-Maraist, Seconded by Lord.

Motion passed unanimously.

# b. Ordinance No. 2014-05, Adding Sections to PMC Title 9 and Adopting Statutes by Reference- Misdemeanors and Gross Misdemeanors

Police Chief Townsend reported there are a number of Revised Code of Washington (RCW) and Washington Administrative Code (WAC) law that already exist in state law; they are being incorporating those laws into the Poulsbo Municipal Code. By adopting these RCW's and WAC's, to send these misdemeanor cases into our Poulsbo Municipal Court, instead of sending them to Kitsap County District Court. If the City doesn't refer to these RCW's and WAC's in the municipal code, we must send them to District Court.

**Motion:** Move to approve Ordinance No. 2014-05 of the City of Poulsbo, Washington adopting by reference various sections of Titles 7, 9, 69, 79, and 81 of the Revised Code of Washington and various sections of Chapter 308 of the Washington Administrative Code in order to establish crimes designated by the state as misdemeanors and gross misdemeanors as criminal offenses under the city's municipal code.

Action: Approve, Moved by Lord, Seconded by Stern.

Motion passed unanimously.

# c. Ordinance No. 2014-06, Amending Sections to PMC Title 9 and Adopting Statutes by Reference- Misdemeanors and Infractions

**Motion:** Move to approve Ordinance No. 2014-06 of the City of Poulsbo, Washington amending chapters 6.01, 9.02, 9.40, 9.70 and 12.28 of the Poulsbo Municipal Code and adopting by reference state laws establishing various misdemeanor crimes and infractions; providing for severability and establishing an effective date.

Action: Approve, Moved by Lord, Seconded by Henry.

Motion passed unanimously.

# d. County/City Hazard Mitigation Plan

Mike Gordon, Kitsap Council Department of Emergency Management (KCDEM) Interim Director, explained the purpose of the Hazard Mitigation Plan. By adopting the plan, the City would be eligible for Hazard Mitigation funding from FEMA.

**Motion:** Move to adopt the Revised Kitsap County City/County Multi-Hazard Mitigation Plan.

Action: Approve, Moved by Henry, Seconded by Musgrove.

Motion passed unanimously.

- **a.** <u>Finance/Administration Committee</u>: Councilmember Mucgrove reported on review of the Real Estate Excise Tax and the surplus items will be coming forward to council.
