

### POULSBO CITY COUNCIL MEETING OF JULY 9, 2014

Mayor Erickson presented Allen with a Certificate of Appreciation for all the work he did on the trail.

#### **6.BUSINESS AGENDA**

#### a. Purchase and Sale Agreement – Holm Property

Parks and Recreations Director McCluskey reported the Recreation and Conservation Office (RCO) approved a grant amendment to the City of Poulsbo to purchase the Holm property as a part of Fish Park. This property is 3.77 acres of vacant land at the north end of the park along Bond Road, and was appraised at \$85k. The City has done its due diligence on the site, and there are no environmental concerns, though some debris clean up will be needed. The RCO grant funds and existing matching funds will pay for the property and associated work.

One of the challenges that the city has faced is how to get pedestrians across the estuary, and connecting the west and east sides of the park. The purchase of this property will allow for a future expansion of a pedestrian path around the entire 40 acre site, as the Holm property has a concrete pedestrian bridge across Dogfish Creek. There will be no need for a suspension bridge over the estuary at this time.

**Motion:** Move to approve the Purchase and Sale Agreement for the Holm Property as presented and authorize the mayor to sign the agreement. **Action:** Approve, **Moved by** Berry-Maraist, **Seconded by** Henry. Motion passed unanimously.

#### b. Note: Semi-Annual Mayors Report

Mayor Erickson outlined the accomplishments in each of the City departments; as well as her accomplishments both in City and regionally.

Council discussion included:

• The need to sell the old Police Department; and the beneficial impact to the construction of the new Public Works facility.

Council discussed not to including the old Police Department, as the old City Hall was a specific/ambitious goal. The Police Department is a simple sale.

*Council consensus:* Keep goal until a later date and modify objectives and progress.
