## POULSBO CITY COUNCIL MEETING OF JANUARY 13, 2016

### MINUTES

## 1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mayor Erickson called the meeting to order in the Council Chambers at 6:00 PM and noted council will be adjourning into a one hour Executive Session for discussion of potential litigation per RCW 42.30.110(1)(i).

Mayor Erickson re-opened the meeting in the Council Chambers at 7:00 PM and led the Pledge of Allegiance.

#### 2. AGENDA APPROVAL

Mayor Erickson recommended approval of the agenda as written.

**Motion:** Move to approve the agenda as written. **Action:** Approve, **Moved by** Stern, **Seconded by** McGinty. Motion passed unanimously.

#### 3. COMMENTS FROM CITIZENS

Mayor Erickson asked for citizen comments; no comments were received.

# 4. MAYOR'S REPORT AND COUNCIL COMMENTS

Councilmember Stern passed out computer terminal calendars he received from the Association of Washington Cities. Stern noted January 27<sup>th</sup> & 28<sup>th</sup> he along with the Mayor will be attending the AWC Conference in Olympia and dinner with the legislature.

Mayor Erickson reported she is still receiving questions regarding the Jim Porter Incident and noted there is a detailed list of documents, including the videos of that night, on the City's website to help answer any questions the public might have. Erickson mentioned she gave her State of the City address to the Greater Poulsbo Chamber today and was sad to hear their director Mark Abshire was leaving.

## 5. CONSENT AGENDA

Motion: Move to approve Consent Agenda items a through b.

## 6. BUSINESS AGENDA

## a. Parks & Recreation Commission Appointment – Amanda Cheatham

Parks & Recreation Director McCluskey reported she had known Amanda Cheatham for quite some time, Amanda has volunteered with the Parks & Recreation Department, and she recommends her for this position.

Amanda Cheatham thanked council and staff for giving her this opportunity.

Motion: Move to concur with Mayor Erickson's appointment of Amanda Cheatham to the Parks & Recreation Commission with a term expiration of December 31, 2018.
Action: Approve, Moved by Thomas, Seconded by Stern.
Motion passed unanimously.

## b. Ordinance No. 2016-01, Adoption of Utility Tax Ordinance

Finance Director Booher stated this ordinance came out of the budget process and it lowers the utility tax on water and sewer from 12% to 9%. Mayor Erickson stated if the cash flow remains strong, the percentage could decrease further.

**Motion:** Move to approve Ordinance No. 2016-01, an ordinance of the City of Poulsbo's to decrease the tax rate on the furnishing of water and sewer from 12% to 9%.

Action: Approve, Moved by McGinty, Seconded by Henry.

Motion passed unanimously.

# c. Parks & Recreation Open Space Plan

Parks & Recreation Director McCluskey noted the Parks & Recreation Department along with the Parks Recreation Commission spent the entire 2015 working on the Open Space Plan which they are required to complete every six years.

Senior Planner Boughton presented an overview of the Open Space Plan, including: the plan needs to be completed every six year to remain eligible for State & Federal grants; to remain consistent with the 2016 Comprehensive Plan Update; remain consistent with Capital Improvement Programming Budget Process; the PROS plan must include Goals & Objectives, Inventory of Facilities, Demand and Needs Analysis, Level of Service Assessment, and a Resolution adopting this plan; a community survey was completed in March/April 2015; through the survey it was found that Fish Park is the most visited park in Poulsbo; the survey found the top priorities to be developing of more trails, increasing shoreline acquisition, and more active parks, playgrounds, or ball fields; the Parks and Recreation Commission had six meetings and hosted a community open house; the Parks and Recreation Commission reviewed the PROS plan and agreed with the following: Goals and Policies, Inventory of Facilities, Demand and Needs Analysis, Level of Service Assessment, and the Capital Improvement Program, Park Impact Fee Analysis; Park Impact fees are only collected by residential units not commercial; Parks and Recreation Commission recommends approval of the 2016 PROS Plan.

**Motion:** Move to approve Resolution No. 2016-02, adopting the 2016-2021 Park Recreation and Open Space Plan as presented; and be included in the City's 2016 Comprehensive Plan Update.

**Action:** Approve, **Moved by** Henry, **Seconded by** Lord. Motion passed unanimously.

# d. Summerset PUD Division 3 Plat Extension Request

Councilmember Stern recused himself due to a professional relationship with David Smith.

Associate Planner Boughton reported: David Smith has requested an extension of the Summerset Division 3 plat validity for an additional 3 month period; plat was due to expire on January 28, 2016 (after the City Council approved a one year extension on November 5, 2014); the PMC does allow for additional extensions as granted by the city council; Summerset Development LLC has completed and final platted Division 1 and 2; it is an additional 28 lots in which the infrastructure work is nearly completed in order to submit for final plat. Boughton noted staff does concur with the extension request.

**Motion:** Move to approve the requested extension for the validity of the Summerset Division 3 Preliminary Plat/PUD for three additional months and thereby requiring that the developer submit final plat application for Division 3 to the City no later than April 28, 2016.

**Action:** Approve, **Moved by** McGinty, **Seconded by** Henry. Motion passed unanimously.

# e. Establish 2016 Comprehensive Plan Site Specific Re-designation Request Docket

Associate Planner Boughton reported: a kickoff workshop was held in June 2015; the city is undertaking a periodic review and update of its Comprehensive Plan and development regulations; this year it is required by the Washington State Growth Management Act to coincide with the eight year cycle; all the cities in Kitsap County are reviewing their Comprehensive Plans and Development Regulations and must have it completed by June 30, 2016; they have incorporated any site specific redesignation requests that have came forward to the city to consider them concurrently with the 2016 periodic update process; the deadline for the site specific re-designation application requests was November 16, 2015 and one application was received; the following chapters of the Comprehensive Policy Document are expected to amended: Land Use, Transportation, Natural Environment, Capital Facilities, Housing, Parks & Recreation and Open Space, and Economic Development; incorporate the Buildable Lands Report data and land capacity analysis into the Comprehensive Plan.

**Motion:** Move to approve the 2016 Comprehensive Plan Periodic update Docket as set forth in the 2016 Comprehensive Plan Amendment Docket staff memo, and including one site specific amendment CPA 2016-01.

**Action:** Approve, **Moved by** McGinty, **Seconded by** Musgrove. Motion passed unanimously.
