RESOLUTION NO. 2009-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, TO CONSIDER THE ADOPTION OF (1) A STORMWATER MANAGEMENT ORDINANCE AND (2) AMENDMENTS TO POULSBO MUNICIPAL CODE 12.02 TO ADOPT A STORMWATER MANUAL AND ADDRESS OTHER TECHNICAL REQUIREMENTS AS REQUIRED BY THE CITY'S NPDES PERMIT, AND ESTABLISHING DECEMBER 16, 2009 AT 7:15 PM, OR AS SOON THEREAFTER AS THE MATTER MAY BE HEARD, AS THE DATE FOR A PUBLIC HEARING TO CONSIDER THE ADOPTIONS.

WHEREAS, the City's NPDES (National Pollutant Discharge Elimination System) permit identifies measures that must be implemented in order to be in compliance with the permit, and

WHEREAS, one of the measures includes passage of an ordinance to address runoff from new development, redevelopment, and construction sites, and

WHEREAS, compliance with the permit will be achieved by the adoption of (1) a stormwater management ordinance which addresses the runoff control elements required to be codified by the permit, except for those items related to the adoption of a stormwater manual, and (2) amendments to Poulsbo Municipal Code 12.02, Construction and Development Standards, to include the adoption of a stormwater manual and other technical requirements of the NPDES permit; now therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Hearing Set. The date and time of December 16, 2009 at 7:15 PM or as soon thereafter as the matter may be heard, is hereby established as the date on which the Poulsbo City Council will hold a public hearing to consider the adoption of (1) a stormwater management ordinance which addresses the runoff control elements required to be codified by the City's NPDES permit, except for those items related to the adoption of a stormwater manual, and (2) amendments to Poulsbo Municipal Code 12.02 to adopt a stormwater manual and address other technical requirements required to be codified by the City's NPDES permit. The hearing will be held in the Council Chambers at Poulsbo City Hall.

Section 2. Notice. The City Clerk is hereby directed to post written notice of the hearing in three of the most public places in the City. The notice shall be posted at least twenty (20) days in advance of the hearing.
