

ORDINANCE NO. 2007-17

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SECTION 2.16.010 OF THE POULSBO MUNICIPAL CODE IN ORDER TO ADD PROVISIONS REGARDING THE DESIGNATION OF THE POULSBO MUNICIPAL COURT AS A COURT OF RECORD; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the Poulsbo Municipal Court Judge and Court Administrator have recommended that language be added to Section 2.16.010 of the Poulsbo Municipal Court in order to expressly designate the Poulsbo Municipal Court as a court of record under applicable statutes and court rules, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON,  
DO ORDAIN AS FOLLOWS:

**Section 1.     Municipal Court as Court of Record.**     Section

2.16.010 of the Poulsbo Municipal Code is hereby amended to read as follows:

**2.16.010     Established**

A.     Established.     There is established a municipal court entitled "the Municipal Court of the City of Poulsbo," hereinafter referred to as a "municipal court," which court shall have jurisdiction and shall exercise all powers enumerated herein and in Chapter 3.50 RCW, as presently existing or hereafter amended, together with such other powers and jurisdiction as are generally conferred upon such court in this state either by common law or by express statute.

B.     Court of record.     The City of Poulsbo Municipal Court shall herewith be designated a court of record under the statutes and court rules of the state of Washington, pursuant to Article 4, Section 11 of the Constitution of the state of Washington, RCW 2.04.190, 3.02.020 through 3.02.040, 3.50.010, Rules of General




Application Court Rule GR29, and the Rules of Court  
RALJ 5.1 through 6.4.


**Section 2. Severability.** If any section, sentence, clause or phrase of  
this ordinance should be held to be invalid or unconstitutional by a court of competent  
jurisdiction, such invalidity or unconstitutionality shall not affect the validity or  
constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 3. Effective Date.** This ordinance shall take effect and be in full  
force five (5) days after publication of the attached summary, which is hereby approved.


