ORDINANCE NO. 2007-28

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, VACATING A PORTION OF THE RIGHT-OF-WAY FOR BOND ROAD NE LOCATED NEAR THE INTERSECTION OF BOND ROAD NE AND VETTER ROAD NW; WAIVING COMPENSATION; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, as part of the settlement of a SEPA appeal for the Bond Road sewer pump station project, the Poulsbo City Council agreed to consider vacating a portion of Bond Road NE in the vicinity of Vetter Road NW, and

WHEREAS, the Poulsbo City Council passed Resolution No. 2007-17 on July 18,

2007 establishing August 15, 2007 as the date for a public hearing on the vacation of the rightof-way, and

WHEREAS, notice of the public hearing was given in the manner provided by law for street vacation hearings and the Poulsbo City Council held the public hearing as scheduled and heard testimony from all interested parties, and continued the public hearing to September 5, 2007, in order to allow for additional testimony and information, and

WHEREAS, after considering the testimony and the information presented by City staff the Poulsbo City Council decided to vacate the right-of-way and hereinafter provided, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO HEREBY ORDAIN AS FOLLOWS:

Section 1. Findings. The Poulsbo City Council finds that:

A. That portion of the right-of-way for which vacation is sought is surplus to the City's needs and there is no reasonable likelihood that the property will be used for road purposes; and

B. The vacation of the right-of-way would not impair access to any property or otherwise impinge upon the property rights or the City or any private landowner; and

C. There is no reasonable likelihood that utilities would be installed within the portion of the right-of-way for which vacation is sought and there is no need for the City to retain an easement in the vacated right-of-way for utility purposes; and

D. Because of the location of the portion of the right-of-way sought to be vacated, the portion sought to be vacated has little value or utility, except to the owner of the adjacent property.

Section 2. Vacation. Subject to the recording with the Kitsap County Auditor of an Access Easement and Boundary Line Agreement by and between Stanton and Jane Brand, Clair and Laverne Thorp, Steven and Frances Powell, and Dorothy Holm in connection with Vetter Road NW, that certain portion of the right-of-way of Bond Road NE in the vicinity of Vetter Road NW, legally described on Exhibit A and depicted on Exhibit B, both of which exhibits are attached hereto and incorporated herein by reference as if set forth in full, is hereby vacated.

<u>Section 3.</u> <u>Compensation</u>. No compensation shall be required from the adjacent property owners in exchange for the vacation.

<u>Section 4.</u> <u>Duties of City Clerk</u>. The City Clerk is hereby authorized and directed to file a copy of this ordinance of record in the office of the Kitsap County Auditor only when the condition listed in Section 2 has been satisfied.

<u>Section 5.</u> <u>Severability</u>. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 6. Effective Date. This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved.
