ORDINANCE NO. 2007-31

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING THE NAME OF CHAPTER 9.02 TO GENERAL - STATUTES ADOPTED BY REFERENCE; AND ADOPTING BY REFERENCE VARIOUS SECTIONS OF TITLES, 9, 9A, 10, 13, 18, 19, 26, 28A, 70, 74, AND 81 OF THE REVISED CODE OF WASHINGTON IN ORDER TO ESTABLISH CRIMES DESIGNATED BY THE STATE AS MISDEMEANORS AND GROSS MISDEMEANORS AS CRIMINAL OFFENSES UNDER THE CITY'S MUNICIPAL CODE; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Poulsbo is concerned about the safety and welfare of its citizens; Now, Therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO DO ORDAIN AS FOLLOWS:





On the 3<sup>rd</sup> day of October, 2007, the City Council of the City of Poulsbo, passed Ordinance No. 2007-31. A summary of the content of said ordinance, consisting of the title, provides as follows:

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING THE NAME OF CHAPTER 9.02 TO GENERAL - STATUTES ADOPTED BY REFERENCE; AND ADOPTING BY REFERENCE VARIOUS SECTIONS OF TITLES, 9, 9A, 10, 13, 18, 19, 26, 28A, 70, 74, AND 81 OF THE REVISED CODE OF WASHINGTON IN ORDER TO ESTABLISH CRIMES DESIGNATED BY THE STATE AS MISDEMEANORS AND GROSS MISDEMEANORS AS CRIMINAL OFFENSES UNDER THE CITY'S MUNICIPAL CODE; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.
