ORDINANCE NO. 2007-51

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SUBSECTION 10.08.010(B)(2) OF THE POULSBO MUNICIPAL CODE IN ORDER TO REDUCE THE SPEED LIMIT ON LINCOLN ROAD N.E. FROM SR 305 TO LARSON COURT FROM THIRTY-FIVE MILES PER HOUR TO TWENTY-FIVE MILES PER HOUR AND FROM LARSON COURT TO A POINT 300 FEET NORTH OF PUGH ROAD N.E. TO THIRTY MILES PER HOUR; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Subsection 10.08.010(B)(2) of the Poulsbo Municipal Code establishes a speed limit of thirty-five miles per hour on Lincoln Road N.E., from SR 305 easterly to the city limits, and

WHEREAS, Public Works Director and Project Engineer have recommended that the speed limit on Lincoln Road N.E. be reduced to twenty-five miles per hour from the intersection of Lincoln Road N.E. and SR 305 to the intersection of Lincoln Road N.E. and Larson Court, and also be reduced to thirty miles per hour from the intersection of Lincoln Road N.E. and Larson Court to a point 300 feet north of Pugh Road N.E., now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON,
DO ORDAIN AS FOLLOWS:

Section 1. **Speed Limit on Lincoln N.E.** Subsection 10.08.010(B)(2) of the Poulsbo Municipal Code is hereby amended to read as follows:


2. Lincoln N.E., from the intersection with State Highway 305 thence easterly along Lincoln Road N.E. to the intersection of Lincoln Road N.E. and Larson Court, twenty-five miles per hour; thence continuing northeasterly along Lincoln Road N.E. from the

intersection of Lincoln Road N.E. and Larson Court to a point three hundred feet north of Pugh Road N.E., thirty miles per hour; thence continuing northeasterly along Lincoln Road N.E. from said point three hundred feet north of Pugh Road N.E. to the city limits, thirty-five miles per hour.


Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.



SUMMARY OF ORDINANCE NO. 2007-51

On the 10th day of October, 2007, the City Council of the City of Poulsbo, passed Ordinance No. 2007-51. A summary of the content of said ordinance, consisting of the title, provides as follows:
