ORDINANCE NO. 2007-55

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SUBSECTION 2.04.030(C) OF THE POULSBO MUNICIPAL CODE IN ORDER TO REVISE THE MANNER IN WHICH COMMITTEES OF THE CITY COUNCIL ARE APPOINTED; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, PMC 2.04.030(C) establishes the manner in which committees of the Poulsbo City Council are appointed, and

WHEREAS, the Council desires to revise the appointment process in order to improve the efficiency of the appointment process and to ensure continuity and productivity of the committees, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON,  
DO ORDAIN AS FOLLOWS:

**Section 1. Committee Appointment Process.** Subsection

2.04.030(C) of the Poulsbo Municipal Code is hereby amended to read as follows:

C. Each committee shall consist of three members of the city council appointed as follows:

1. Committee assignments shall become effective on February 1 of every even-numbered year.

2. The city council will hold a workshop meeting in early January of each even-numbered year in order to review councilmembers' requests for committee assignments and to determine who will serve on each committee. All councilmembers will submit their prioritized requests for committee assignments in writing prior to the meeting. The mayor shall chair the meeting, but assignments shall be decided by the city council.

3. In order to ensure continuity on committees, at least one councilmember from the previous term shall remain on the committee.

4. Committee members shall serve for two years or until a successor is appointed. Newly elected councilmembers will serve in their predecessor's committee assignment until the new committee assignments begin in February.

**Section 2.** **Severability.** If any section, sentence, clause or phrase of this ordinance or any code section adopted or amended hereby should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance or any code section adopted or amended hereby.

**Section 3.** **Effective Date.** This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.


