ORDINANCE NO. 2008-04

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REPEALING CHAPTERS 10.20 AND 12.34 OF THE POULSBO MUNICIPAL CODE RELATING TO COMMUTE TRIP REDUCTION AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the state legislature has amended the Commute Trip Reduction Act, RCW 70.94.521, *et seq.*, in order to change the criteria for determining which local jurisdictions are required to adopt commute trip reduction plans and ordinances, and

WHEREAS, prior to the amendment, the City of Poulsbo was required to adopt a commute trip reduction plan and ordinance, but the City is no longer required to do so based on the amendment, and

WHEREAS, the Poulsbo City Council has therefore decided to repeal Chapters 10.20 and 12.34 of the Poulsbo Municipal Code relating to commute trip reduction, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON,
DO ORDAIN AS FOLLOWS:

Section 1. Repeal of Commute Trip Reduction Regulations.

Chapters 10.20 and 12.34 of the Poulsbo Municipal Code are hereby repealed.

Section 2. Effective Date. This ordinance shall take effect and be in

full force five (5) days after publication of the attached summary, which is hereby approved.


