

ORDINANCE NO. 2008-15

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SECTION 10.04.015 OF THE POULSBO MUNICIPAL CODE IN ORDER TO REVISE THE LIST OF STATE STATUTES ADOPTED THEREIN BY REFERENCE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Section 10.04.015 of the Poulsbo Municipal Code adopts several state statutes by reference, as amended by certain 1994 session laws, and

WHEREAS, Section 10.04.015 was enacted in 1994, after the state legislature had adopted several new statutes and amendments relating to traffic, and

WHEREAS, the majority of the statutes and session laws adopted by Section 10.04.015 have since been adopted into the Model Traffic Ordinance, which the City of Poulsbo has adopted in Section 10.04.010 of the Poulsbo Municipal Code, and

WHEREAS, adoption of the statutes and session laws into the Model Traffic Ordinance makes their adoption in Section 10.04.015 duplicative and the Poulsbo City Council has determined to modify Section 10.04.015 accordingly, NOW, THEREFORE,

Section 1. **State Statutes Adopted by Reference.** Section 10.04.015 of the Poulsbo Municipal Code is hereby amended to read as follows:

10.04.015 State Statutes adopted by reference.

The following state statutes, as the same now exist or as the same may be hereafter amended, are hereby adopted by this reference as if set forth in full:

1. RCW 46.61.5056 - Alcohol violators - Information school - Evaluation and treatment;

2. RCW 46.61.5151 - Sentences - Intermittent fulfillment - Restrictions;

3. RCW 46.61.5152 - Attendance at program focusing on victims.

Section 2. Effective Date. This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.
