<u>Section 1</u>. **<u>Findings</u>**. The Poulsbo City Council finds that:

A. That portion of the right-of-way for which vacation is sought is surplus to the City's needs and there is no reasonable likelihood that the property will be used for road purposes; and

B. Upon completion of the requirements in Section 6, the vacation of the right-of-way would not impair access to any property or otherwise impinge upon the property rights or the City or any private landowner; and

C. There is currently utilities installed within the portion of the right-of-way for which vacation is sought and the City will retain an easement in the vacated right-of-way for utility purposes; and

<u>Section 2.</u> <u>Vacation</u>. That certain portion of the right-of-way of Eighth Avenue NE, legally described on Exhibit A and depicted on Exhibit B, all of which exhibits are attached hereto and incorporated herein by reference as if set forth in full, is hereby vacated upon completion of the requirements set forth in Section 6.

<u>Section 3.</u> <u>Compensation</u>. No compensation shall be required for the adjacent property owners in exchange for the vacation.

Section 6. Effective Date. This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved, provided, that vacation of the right-of-way as provided in Section 2 shall not become effective unless and until this ordinance is recorded by the City Clerk as provided in Section 4. The City Clerk is authorized and directed to record this ordinance only upon receipt of an executed easement agreed to by Haakon Rommen, or their successors in interest or assigns, as grantors and the owners of tax parcel 4229-000-013-0002 as grantees, providing ingress, egress and utilities over, under, and across the vacated right-of-way as described on Exhibit B. Upon receipt of the easement, the City Clerk shall record, or cause to be recorded, both this ordinance and the easement and vacation of the right-of-way shall thereupon become effective.
