AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON ADDING A NEW SECTION 9.60.015 MALICIOUS MISCHIEF TO PMC CHAPTER 9.60 AND ADOPTING RCW 9A.48.105 CRIMINAL STREET GANG TAGGING AND GRAFFITI; ADDING A NEW SECTION 9.80.025 VEHICLE AND VESSEL TITLES – STATUTES ADOPTED BY REFERENCE AND ADOPTING RCW 64.44.045 VEHICLE AND VESSEL TITLES TO PMC CHAPTER 9.80; ADOPTING RCW 18.280.140 HOME INSPECTION VIOLATION IN PMC CHAPTER 9.02, SECTION 9.02.520; ADOPTING RCW 77.15.740 PROTECTION OF SOUTHERN RESIDENT ORCA WHALES IN PMC CHAPTER 6.01, SECTION 6.01.210; AND PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Poulsbo is concerned about the safety and welfare of its citizens and marine life, and

WHEREAS, the City Council of the City of Poulsbo is adopting new legislation that was passed in the 2008 State Legislative Session, Now, Therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO DO ORDAIN AS FOLLOWS:

Section 1. A new section is added to Chapter 9.60 of the Poulsbo Municipal Code to read as follows:

9.60.015 Malicious mischief - Statutes adopted by reference

Pursuant to the authority contained in RCW 35A.12.140 the following sections of Chapter 9A.48 RCW as enacted or hereinafter amended are hereby adopted by reference as if fully set forth herein including penalties.

9A.48.105 Criminal street gang tagging and graffiti

Section 2. A new section is added to Chapter 9.80 of the Poulsbo Municipal Code to read as follows:

9.80.025 Vehicle and Vessel Titles – Statutes adopted by reference

Pursuant to the authority contained in RCW 35A.12.140 the following sections of Chapter 64.44 RCW as enacted or hereinafter amended are hereby adopted by reference as if fully set forth herein including penalties.

64.44.045 Vehicle and vessel titles – notice of contamination or decontamination – penalty

Section 3. PMC Section 9.02.520 is amended to add RCW 18.280.140 relating to Home Inspections to the list of statutes adopted therein and to read as follows:

9.02.520 Business regulations – miscellaneous – statues adopted by reference

Pursuant to the authority contained in RCW 35A.12.140 the following sections of Chapter 19.94 and 18.280 RCWs as enacted or hereinafter amended are hereby adopted by reference as if fully set forth herein including penalties.

Section 4. PMC Section 6.01.210 is amended to add RCW 77.15.740 relating to Protection of southern resident orca whales to the list of statutes adopted therein and to read as follows:

<u>6.01.210</u> Fish and wildlife enforcement code and licenses- statutes adopted by reference Pursuant to the authority contained in RCW 35A.12.140 the following sections of Chapter 77.15, and 77.32 RCW as enacted or hereinafter amended are hereby adopted by reference as if fully set forth herein including penalties.
