

**ORDINANCE NO. 2008-20**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SUBSECTION 3.12.090(B) OF THE POULSBO MUNICIPAL CODE IN ORDER TO RAISE THE HOURLY FEES FOR USE OF PUBLIC MEETING ROOMS IN THE VALBORG OYEN PUBLIC LIBRARY; PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, PMC 3.12.090(B) establishes hourly fees for the use of public meeting rooms in the Valborg Oyen Public Library, and

**WHEREAS**, the cost of maintaining and operating the public meeting rooms and the library building has risen since the fees were established in 2003, and

**WHEREAS**, the Community Services Committee of the Poulsbo city Council has reviewed the fees and has recommended that the same be raised in order to better address the maintenance and operations costs, now, therefore,

**THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1. Fees.** Subsection 3.12.090(B) of the Poulsbo Municipal Code is hereby amended to raise the hourly fees for use of the public meeting rooms at the Valborg Oyen Public Library and to read as follows:

B. Library Community Room - Fees. The fee for use of public meeting rooms in the Valborg Oyen Public Library shall be as follows:

Friends of the Library Organization	No charge
Nonprofit groups	\$15.00 per hour
Governmental entities	\$25.00 per hour
Commercial or private parties	\$30.00 per hour

**Section 2. Severability.** If any section, sentence, clause or phrase of this ordinance or any code section adopted or amended hereby should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall


not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance or any code section adopted or amended hereby.

**Section 3. Effective Date.** This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.


