



ORDINANCE NO. 2009-08

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON
AMENDING SECTION 5.28.120 OF THE POULSBO
MUNICIPAL CODE TO CHANGE THE TERM IN WHICH TAXI
LICENSES EXPIRE; PROVIDING FOR SEVERABILITY AND
ESTABLISHING AN EFFECTIVE DATE

WHEREAS, Section 5.28.120 of the Poulsbo Municipal Code provides that
a taxicab permits expire June 30 following the date of issue; and

WHEREAS, City Business Licenses expire December 31 following the date
of issue; and

WHEREAS, it is in the best interest of the City and the business
owners to provide consistent licensing requirements;

**THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON,
DO ORDAIN AS FOLLOWS:**

Section 1. Term. Section 5.28.120 of the Poulsbo Municipal Code is
hereby amended to read as follows:

5.28.120 All permits expire December 31 following the date of
issue, but may be reissued for succeeding years to the
same permit holder and the same motor vehicle when
the requirements of this article are otherwise met.

Section 2. Severability. If any section, sentence, clause or phrase of
this ordinance should be held to be invalid or unconstitutional by a court of
competent jurisdiction, such invalidity or unconstitutionality shall not affect the
validity or constitutionality of any other section, sentence, clause or phrase of
this ordinance.


Section 3. Effective Date. This ordinance shall take effect and be in full
force five (5) days after publication of the attached summary, which is hereby
approved.


