**ORDINANCE NO. 2009-15**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SECTION 2.84.015 OF THE POULSBO MUNICIPAL CODE IN ORDER TO CHANGE THE MEETING TIME FOR THE CIVIL SERVICE COMMISSION FROM SEVEN PM (7:00 PM) TO THREE PM (3:00 PM); PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, Section 2.84.015 of the Poulsbo Municipal Code sets forth the date and time for meeting of the Poulsbo Civil Service Commission, and

**WHEREAS**, the Poulsbo Civil Service Commission has requested that the City Council amend Section 2.84.015 in order to change the time for regular meetings to the Commission from 7:00 PM to 3:00 PM, and

**WHEREAS**, the City Council agrees with the request and recommendation, now, therefore,

**THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:**

Section 1. Meetings of Poulsbo Civil Service Commission. Section 2.84.015 of the Poulsbo Municipal Code is hereby amended to read as follows:


**2.84.015 Meetings**

The Civil Service Commission shall meet the first Monday of each month at three p.m. in the City Hall. In the event that any regular meeting date falls upon a city holiday, the meeting shall be conducted on the next regular business day unless a special meeting date is set in advance. Special meetings may be scheduled and conducted by giving notice in accord with the State Open Public Meetings Act. If a commissioner has three or more successive unexcused absences from any regular or special meetings of the commission, the mayor, upon the recommendation of the commission, may remove said commissioner from office.

Section 2.     Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.


Section 3.     Effective Date. This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved.


