#### ORDINANCE NO. 2010-04

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REVISING SECTION 12.02.010 OF THE POULSBO MUNICIPAL CODE TO REFLECT UPDATED AND ADOPTED STANDARDS; AND FIXING A TIME WHEN THE SAME SHALL BECOME EFFECTIVE.

**WHEREAS**, the regulation and management construction and development activities is a function of the City of Poulsbo; and

**WHEREAS**, the City of Poulsbo Municipal Code lists relevant construction standards adopted by the City of Poulsbo; and

**WHEREAS**; the City of Poulsbo has adopted updated construction standards; NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

**Section 1. Construction and Development Standards.** Section 12.02.010 of the Poulsbo Municipal Code is hereby revised to read as follows:

- 4. The Low Impact Development Guidance Manual, a Practical Guide to LID Implementation in Kitsap County, published by the Kitsap Home Builders Foundation;
- **Section 2. Severability.** If any section, sentence, clause or phrase of this ordinance or any code section adopted or amended hereby should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance or any code section adopted or amended hereby.
- **Section 3. Effective Date.** This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.
