## **ORDINANCE NO. 2010-05**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON EXTENDING THE TERM OF THE CONTRACT BETWEEN THE CITY AND BAINBRIDGE DISPOSAL INC. FOR CURBSIDE RECYCLING.

**WHEREAS**, in September 2003 the City of Poulsbo entered into a contract with Bainbridge Disposal Inc. for curbside recycling services, and

**WHEREAS**, Section 1.2.0 of said contract states: "The term of this Contract is for five years, starting October 1, 2003, and expiring September 30, 2008. The City reserves the right, at its sole option, to extend the Contract for up to two separate extensions, each of which shall not exceed two years. Any such extension shall be under the original terms and conditions of this Contract as may be amended. To exercise its option to extend this Contract, notice shall be given in writing by the City to the Contractor by December 31st of the year prior to the expiration of the Contract term or the expiration of a previous extension. Extension of contract must be authorized by Council.", and

**WHEREAS**, the City of Poulsbo previously exercised the first two-year extension of the contract through September 30, 2010, and,

**WHEREAS**, the City of Poulsbo wishes to exercise the second two-year extension to said contract, NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

The Mayor of the City of Poulsbo is hereby authorized to extend the term of this contract by two years with the resulting expiration date of September 30, 2012.
