#### ORDINANCE NO. 2010-15

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING THE PROVISIONS OF POULSBO MUNICIPAL CODE CHAPTER 3.62.030 REGARDING PETTY CASH FUNDS-TO CREATE A CHANGE FUND FOR THE PLANNING AND ENGINEERING DEPARTMENT AND AMEND THE PETTY CASH FUND AMOUNT AND THE CHANGE FUND AMOUNT FOR THE FINANCE DEPARTMENT AND FIXING A TIME WHEN THE SAME SHALL BECOME EFFECTIVE AND APPROVING AN ORDINANCE SUMMARY FOR PUBLICATION.

WHEREAS, the City of Poulsbo established revolving funds for each Department in 1985;

and

**WHEREAS**, experience has shown that, due to the availability of department credit cards the amount needed of cash on hand has decreased; and

**WHEREAS**, t he Planning and Engineering Department will need a change fund for receipting in cash once the staff move into the new City Hall, now, therefore,

# THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON HEREBY ORDAINS AS FOLLOWS:

**Section 1.** The Poulsbo Municipal Code, Chapter 3.62, section 3.62.030 <u>Balance of funds—Replenishment</u> is hereby amended to read as follows:

<u>3.62.030 Balance of funds—Replenishment.</u> The cash balance in each of the petty cash and change revolving funds created by this chapter is as follows:

| <u>FUND</u>                                 | <u>AMOUNT</u> |
|---|---------------|
| Finance Department petty cash               | \$750.00      |
| Police Department petty cash                | 100.00        |
| Finance Department change fund              | 200.00        |
| Municipal Court change fund                 | 50.00         |
| Planning/Engineering Department change fund | 50.00         |
| Park and Recreation change fund             | 50.00         |
| Police Department change fund               | 25.00         |

Any and all expenditures from and deposits to such funds prior to the effective date of the original ordinance establishing the funds and codified by this chapter have been ratified and approved. As each petty cash revolving fund becomes depleted because of expenditures incurred for supplies or because of other expenses of a minor nature, the finance director, upon request by the appropriate department head, may issue checks to replenish the amount in the fund. The petty cash and change revolving funds created pursuant to this chapter shall constitute clearing funds and are not working funds of the city for budgetary purposes.

**Section 2.** This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.
