

## **ORDINANCE NO. 2011-01**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SUBSECTION 3.12.050(A) OF THE POULSBO MUNICIPAL CODE IN ORDER TO INCREASE FEES CHARGED FOR PARK USE PERMIT APPLICATION FEES AND SUBSECTION 3.12.050(B) IN ORDER TO INCREASE FEES FOR SIGN PERMITS; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, Poulsbo City staff facilitates the reservations and public use of city parks for various activities, and

**WHEREAS**, Poulsbo City staff facilitates the reservation and public use of city signage for community events, and

**WHEREAS**, the City should recover its costs of providing such services and the Poulsbo City Council, upon recommendation of the Parks and Recreation Director, has determined to increase the current charges in order to do so, now, therefore,

**THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON,  
DO ORDAIN AS FOLLOWS:**

**Section 1. Parks and recreation fees and charges.**

Subsection 3.12.050(A) of the Poulsbo Municipal Code is hereby amended to increase the fees described therein and to read as follows:

A. Park Use Permit Application - Fees. The park use permit fees shall be as follows:

1. Social activity permit, thirty dollars per two-hour use; ten dollars each additional hour.
2. Gazebo use, thirty dollars per two-hour use; ten dollars each additional hour.
3. Permitted commercial activity, thirty dollars per use;
4. Public service instructional classes, fifty dollars per session; and

5. Special events, fifty dollars per use.


B. Sign Permit – Fees. The fee for the two community event signs on Highway 305, one at the intersection with Hostmark Street and the other near the intersection with Viking Avenue, shall be twenty five dollars per each one week reservation.

**Section 2. Effective Date.** This ordinance shall take effect and be in full force five days after the date on which the attached summary consisting of the title will be published.


