**ORDINANCE NO. 2012-07**

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REPEALING CHAPTERS 3.52, 3.55, 3.60, 3.61, and 3.64 OF THE POULSBO MUNICIPAL CODE RELATING TO FUNDS AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, Chapters 3.52, 3.55, 3.60, 3.61, and 3.64 of the Poulsbo Municipal Code create several special funds to be used by the City for specific municipal purposes, and

**WHEREAS**, many of the funds are no longer used and recent changes in municipal accounting rules have made other funds obsolete, and

**WHEREAS**, the Poulsbo City Council has therefore decided to repeal Chapters 3.52, 3.55, 3.60, 3.61, and 3.64 of the Poulsbo Municipal Code, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

**Section 1. Repeal of Special Funds.** Chapters 3.52, 3.55, 3.60, 3.61, and 3.64 of the Poulsbo Municipal Code are hereby repealed.


**Section 2. Duties of Codifier.** The codifier of the Poulsbo Municipal Code is hereby authorized and directed to re-order and/or renumber the various remaining chapters of Title 3 of the Poulsbo Municipal Code in order to close the gaps in numbering left by the repeal of the chapters described in Section 1 and to make the Poulsbo Municipal Code more efficient. The Poulsbo City Clerk is authorized and directed to work with the codifier to achieve this result.

**Section 2. Effective Date.** This ordinance shall take effect and be in full force five (5) days after publication of the attached summary, which is hereby approved.


