ORDINANCE NO. 2013-01

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, RELATING TO CHAPTER 12.28 MARINE REGULATIONS; ADDING NEW SECTION 12.28.055 PUBLIC ACCESS AND RECREATION AND PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Poulsbo is concerned about the safety and welfare of its citizens and waterways;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO DO ORDAIN AS FOLLOWS:

Section 1. A new section is added to Chapter 12.28 of the Poulsbo Municipal Code to read as follows:

12.28.055 Public Access and Recreation

Pursuant to the authority contained in RCW 35A.12.140 the following sections of the Washington Administrative Code, Chapter 332-52 WAC as enacted or hereinafter amended are hereby adopted by reference as if fully set forth herein including penalties.

WAC 332-52-155 Anchorage

Section 2. Severability

If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date: This ordinance shall take effect and be in full force five (5) days after the publication of the attached summary, which is hereby approved.
