ORDINANCE NO. 2013-02

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, ADOPTING RCW 69.50.445 MAKING IT A CLASS 3 CIVIL INFRACTION TO OPEN A PACKAGE CONTAINING MARIJUANA, USEABLE MARIJUANA, OR MARIJUANA-INFUSED PRODUCTS, OR TO CONSUME MARIJUANA, USEABLE MARIJUANA, OR MARIJUANA-INFUSED PRODUCTS IN VIEW OF THE GENERAL PUBLIC; AMENDING PMC 9.20.100 TO INCORPORATE RCW 69.50.445 BY REFERENCE; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, RCW 69.50.445 was added to state law by the passage of Initiative 502 by Washington voters in November 2012; and

WHEREAS, RCW 69.50.445 makes it a Class 3 civil infraction to open a package containing marijuana, useable marijuana, or marijuana-infused products or to consume marijuana, useable marijuana, or marijuana-infused products in view of the general public; and

WHEREAS, in order to enable Poulsbo police officers to cite violators of RCW 69.50.445

through the Poulsbo Municipal Court, the City must adopt the RCW by reference; now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Adoption of RCW. RCW 69.50.445, as the same now exists or as the same may be amended in the future, is hereby adopted by reference by the City of Poulsbo and PMC 9.20.100 is hereby amended to read as follows:

9.20.100 Offenses and penalties - Statutes adopted by reference.

Pursuant to the authority contained in RCW 35A.12.140, the following sections of Chapter 69.50 RCW as enacted or hereafter amended are hereby adopted by reference as if fully set forth herein, including penalties:

Section 2. Copy to be Kept on File. Pursuant to RCW 35A.12.140, a copy of RCW 69.50.445, in the form in which it exists at the time this ordinance is adopted, shall be attached to this ordinance kept on file in the office of the City Clerk.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective Date. This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved.

RCW 69.50.445

Opening or consuming package containing marijuana, useable marijuana, or marijuana-infused product in view of general public — Penalty.

It is unlawful to open a package containing marijuana, useable marijuana, or a marijuana-infused product, or consume marijuana, useable marijuana, or a marijuana-infused product, in view of the general public. A person who violates this section is guilty of a class 3 civil infraction under chapter 7.80 RCW.
