## ORDINANCE NO. 2014-11

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, AMENDING SUBSECTION 3.12.050(A) AND SUBSECTION 3.12.050(B) OF THE POULSBO MUNICIPAL CODE IN ORDER TO ALLOW FOR FEE CHANGES BY RESOLUTION AS PROVIDED IN SUBSECTION 3.12.010(B); PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, Poulsbo City staff facilitates the reservations and public use of city parks for various activities, and

**WHEREAS**, Poulsbo City staff facilitates the reservation and public use of two city signs for community events, and

WHEREAS, the City should reduce its costs of updating the fees for providing such services and the Poulsbo City Council, upon recommendation of the Parks and Recreation Director, has determined to allow changes to the current charges by resolution in order to do so, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

<u>Section 1</u>. Amendments to Subsection 3.12.050(A) and Subsection 3.12.050(B) of the Poulsbo Municipal Code. These subsections are hereby amended to read as follows:

**Subsection 3.12.050(A)** 

<u>Parks and recreation fees and charges</u>. The schedule of fees entitled "Park and Recreation Fees and Charges", which is on file in the office of the city clerk, is adopted as the official parks and recreation fee schedule as provided in Section 3.12.010(A). The schedule may be revised from time to time as provided in Section 3.12.010(B).

**Subsection 3.12.050(B)** 

<u>Sign Permit – Fees.</u> The schedule of fees entitled "Park and Recreation Fees and Charges", which is on file in the office of the city clerk, is adopted as the official parks and recreation fee schedule as provided in Section

3.12.010(A). The schedule may be revised from time to time as provided in

Section 3.12.010(B).

Section 2. Severability. If any section, sentence, clause or phrase of this

ordinance or any code section adopted or amended hereby should be held to be invalid

or unconstitutional by a court of competent jurisdiction, such invalidity or

unconstitutionality shall not affect the validity or constitutionality of any other section,

sentence, clause or phrase of this ordinance or any code section adopted or amended

hereby.

Section 3. Effective Date. This ordinance shall take effect and be in full force five

days after the date on which the attached summary consisting of the title will be

published.
