ORDINANCE NO. 2017-03

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON, REPEALING CHAPTER 3.54 OF THE POULSBO MUNICIPAL CODE, ADVANCE TRAVEL EXPENSE REVOLVING FUND; DIRECTING THAT ALL MONIES IN THE SAID FUND BE TRANSFERRED TO THE GENERAL FUND.

WHEREAS, Ordinance 85-15 of the City of Poulsbo, passed by the City Council on March 13, 1985, created an advance travel expense revolving fund pursuant to RCW 4.24.010 and adopted Chapter 3.54 of the Poulsbo Municipal Code to regulate the use of such fund; and

WHEREAS, the Poulsbo City Council has determined that the fund is no longer necessary and that it should be repealed; now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Repeal of Fund. Chapter 3.54 of the Poulsbo Municipal Code is hereby repealed and the advance travel expense revolving fund established by such chapter is hereby dissolved.

Section 2. Transfer of Monies. Any monies in the advance travel expense revolving fund created by Chapter 3.54 shall be transferred to the City's general fund.

Section 3. Severability. If any section, subsection, paragraph, sentence, clause or phrase of this ordinance or its application to any person or situation should be held to be invalid or unconstitutional for any reason by a court of competent jurisdiction, such invalidity

or unconstitutionality shall not affect the validity or constitutionality of the remaining portions of this ordinance or its application to any other person or situation.

Section 4. Effective Date. This ordinance shall take effect five (5) days after publication of the attached summary, which is hereby approved.
