RESOLUTION NO. 2007-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, INITIATING THE VACATION OF A PORTION OF VETTER ROAD NW LYING NORTHWEST OF BOND ROAD NE BETWEEN BOND ROAD NE AND SR 305 AND ESTABLISHING AUGUST 15, 2007 AS THE DATE FOR A PUBLIC HEARING TO CONSIDER THE VACATION.

WHEREAS, as part of the settlement of a SEPA appeal for the Bond Road sewer pump station project, the Poulsbo City Council agreed to consider vacating a portion of Vetter Road NW lying northwest of Bond Road NE between Bond Road NE and SR 305, and

WHEREAS, RCW 35.79.010 permits the Council to initiate vacation of right-of-way by resolution, and

WHEREAS, the Council has determined to initiate the vacation procedure and to hold the public hearing required by RCW 35.79.010, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVE AS FOLLOWS:


Section 1. **Hearing Set.** Pursuant to RCW 35.79.010, the date and time of August 15, 2007 at 7:15 p.m., or as soon thereafter as the matter may be heard, is hereby established as the date and time at which the Poulsbo City Council will hold a public hearing to consider the vacation of that portion of the right-of-way for Vetter Road NW lying northwest of Bond Road NE between Bond Road NE and SR 305 and depicted on Exhibit A attached hereto and incorporated herein by this reference as if fully set

forth. The hearing will be held in the Council Chambers at Poulsbo City Hall, 19050 Jensen Way NE, Poulsbo Washington.

Section 2. **Notice.** The City Clerk is hereby directed to post written notice of the hearing in three of the most public places in the City and a like notice in a conspicuous place on the right-of-way proposed to be vacated. The notice shall be posted at least twenty (20) days in advance of the hearing. In addition, the city Clerk shall mail a notice of the public hearing to owners or reputed owners of lots, tracts, or parcels of land abutting upon the right-of-way proposed to be vacated, as shown on the rolls of the County Treasurer and directed to the address shown thereon. Notice shall also be mailed to such owners at least fifteen (15) days prior to the date of the hearing.

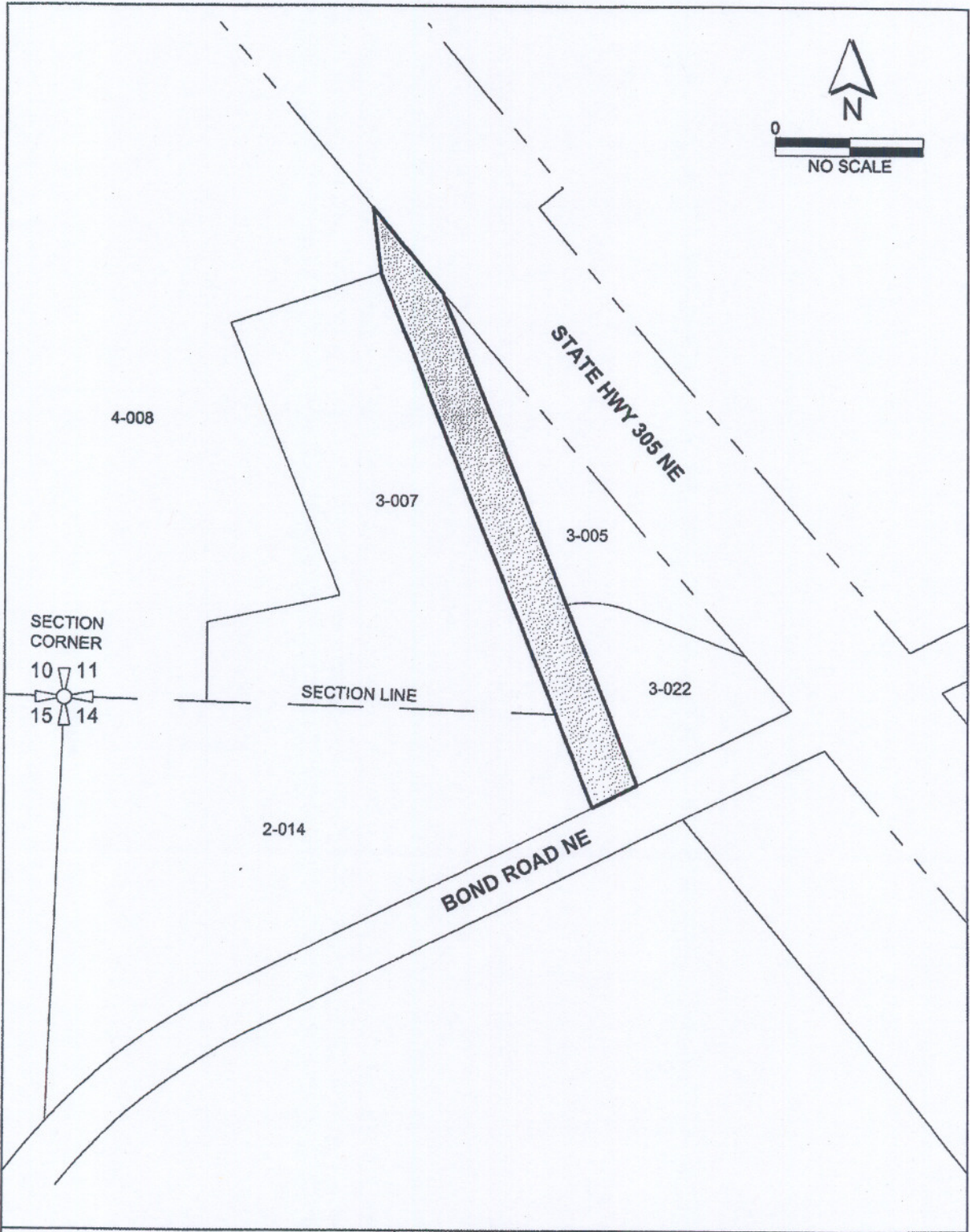
