

RESOLUTION NO. 2009-08

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, AMENDING THE SPONSORSHIP OF THE FIREWORKS ON THE FJORD CELEBRATION FROM the 3RD OF JULY EVENT TO THE VIKING FEST CORPORATION AND GRANTING THE VIKING FEST CORPORATION A LICENSE TO USE ANDERSON PARKWAY AND LIBERTY BAY WATERFRONT PARK DURING THE ANNUAL PUBLIC CELEBRATION IN JULY.

WHEREAS, food and craft concessions and entertainment at the Fireworks on the Fjord celebration stimulate business and tourism, generate revenues to pay for the event and stimulate community pride; now, therefore,


THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, establishes the following conditions to be met by the Viking Fest Corporation, hereinafter known as the Sponsor of the Fireworks on the Fjord, in exercising its license to use public property for the annual celebration in July:

1. Sponsor is granted use of Anderson Parkway for all booths, subject to such conditions as approved by the Chief of Police and the Public Works Superintendent;
2. Sponsor is granted use of Liberty Bay Waterfront Park, subject to such conditions as recommended by the Community Services Committee;
3. Sponsor shall ensure adequate sanitation in all food handling and preparation and in providing restroom facilities, as necessary, subject to such conditions as defined by the Kitsap County Health District;
4. Sponsor and Public Works shall clean up the park following the event, subject to such conditions as approved by the Public Works Superintendent;

5. Sponsor shall ensure adequate electrical safety, fire safety and clear lanes for emergency vehicles, subject to such conditions as approved by the Fire Chief or his designee;
6. Sponsor shall comply with all applicable regulations as provided in Poulsbo Municipal Code 8.20 Fireworks, including but not limited to providing the City with a Certificate of Insurance verifying liability coverage for the event in an amount as specified by the City; and
7. Sponsor shall hold the City harmless from all claims or damages asserted against the City because of this license.
