WHEREAS, December 24, 2009, Christmas Eve falls on a Thursday and minimal public use of city services is anticipated; and


WHEREAS, December 31, 2009, New Years Eve falls on a Thursday and minimal public use of city services is anticipated; and

WHEREAS, the half day closure on Thursday, December 24, 2009 and Friday, December 31, 2009 closures has been requested by employees of the City of Poulsbo and it will increase staff morale to remain closed to the public during those times; now therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

That City of Poulsbo offices will be closed to the public on December 24, 2009 beginning at 12:00 PM and December 31, 2009. Staff has the option of 1) using their accrued vacation leave, personal or floating holiday, or comp time; 2) working during the closure; or 3) taking approved leave without pay if they choose not to work during the closure.
