WHEREAS, the Poulsbo City Council has reviewed the draft public and agency participation plan and has determined to adopt a final public and agency participation plan in the form attached to this resolution,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Adoption. The City of Poulsbo 2010 Comprehensive Plan Amendment Public and Agency Participation Plan, attached to this resolution and incorporated herein by this reference as if set forth in full, is hereby adopted. The City will follow the Public and Agency Participation Plan during the consideration of 2010 Comprehensive Plan Amendments.

City of Poulsbo 2010 Comprehensive Plan Amendment Public and Agency Participation Plan

Introduction:

The Growth Management Act requires local governments to establish a public participation program for the evaluation and update of its comprehensive plan. This public and agency participation plan describes the steps that the City of Poulsbo will take to involve the community. The purpose of the public and agency participation and outreach plan is to inform the public, agencies with jurisdiction, and other interested parties about the update of the City's Comprehensive Plan.

Public and Agency Participation Goals:

- To provide the public with timely information, an understanding of the process, and opportunities to review
 and comment on the comprehensive plan amendments, and to have these comments forwarded to the City's
 decision makers.
- Ensure that information about the process is provided to the public early in the process and at regular intervals thereafter, to maximize public awareness and participation in the process.
- Actively solicit information from citizens, property owners and stakeholders about their concerns, questions
 and priorities for the amendment process and the future of Poulsbo land uses and the City's Comprehensive
 Plan.
- Encourage the public to informally review and comment on the update throughout the process.
- Incorporate public comment into the local government's review process prior to significant milestones or decisionmaking.
- Provide forums for formal public input at milestones prior to decisionmaking by local officials.
- Consult and consider recommendations from neighboring jurisdictions, federal and state agencies, and Native American tribes.

Information Availability:

Documents related to the 2010 Comprehensive Plan Amendment cycle will be available for public review. The primary clearinghouse for information related to the amendments is the city website www.cityofpoulsbo.com where notice of application and environmental review, public hearing notices, findings of fact, and ordinance will be posted. Documents will also be available for review at City Hall. Copies will be provided at a reasonable cost. Publication in the North Kitsap Herald and posting in the Post Office, Library and City Hall notice boards of the notice of application and environmental review, hearing notices, and ordinance summary will also occur.

A mailing list of interested persons and organizations to receive notices regarding meetings will be maintained. Notice will be provided either by mail or e-mail. Individuals interested in being on the mailing list should contact the Poulsbo Planning Department at (360) 779-3006.

Planning Commission and City Council meetings are recorded. Recordings are available for public review or purchase.

How to Comment:

Comments may be provided to the City at any time during the process. Written comments will be taken by the City and forwarded to the recommendation and decision making bodies as part of the record. Send written comments to City of Poulsbo Planning Department, P.O. Box 98, Poulsbo, Washington 98370, or fax them to (360) 697-8269. In addition to receiving comments through regular postal mailing and fax, comments may be

sent to <u>planninginfo@cityofpoulsbo.com</u>. To ensure consideration, all written comments must be received by the City prior to close of the comprehensive plan amendment public hearings.

Verbal public comments will be taken at Planning Commission and City Council Public Hearings for those who wish to address the recommendation and decision making bodies.

- Publication in the North Kitsap Herald on April 16, 2010 requesting comprehensive plan amendments for the 2010 amendment process by June 7, 2010.
- Reserved June 23, 2010 for pre-application meetings with proposed amendment proponents.
- Development of proposed docket.
