A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, REJECTING ALL BIDS RECEIVED BY THE CITY ON THE NOLL ROAD IMPROVEMENTS PHASE I PROJECT NO. CN2010-003.

WHEREAS, the City of Poulsbo recently opened bids on the Noll Road Improvements Phase I Project No. CN2010-003 ("the Project"), and

WHEREAS, the Project is federally funded and the Washington State Department of Transportation ("WSDOT"), as local administrator of the federal funds, has recommended that the City reject all bids due to errors by the low bidder and others in filling out the required Disadvantaged Business Enterprise Utilization (DBE) Certification, and

**WHEREAS**, the City's choice in using an additive/alternate format for the solicitation of bids may have led to confusion on the part of the bidders in how to fill out the DBE Certification and created a difficult bidding environment for all interested contractors, and

**WHEREAS**, changes to the format of the solicitation for bids will alleviate this confusion and result in a better bidding process, and

**WHEREAS**, the City has the authority to reject any and all bids pursuant to RCW 35.23.352 and has determined to accept the recommendation of WSDOT in order to maintain the Project's eligibility for federal funding, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVE AS FOLLOWS:

Section 1. Rejection of Bid. All bids received by the City of Poulsbo on the Project are hereby rejected. The bid deposits received by the City shall be returned to the bidders with notification of the rejection.
