A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, AUTHORIZING THE EXPENDITURE OF FUNDS TO RECOGNIZE EMPLOYEES, OFFICIALS AND COMMUNITY MEMBERS.

WHEREAS, the City of Poulsbo appreciates that recognition of service by employees is an essential of good personnel policy, the promotion of good will, and fostering a sense of pride in affiliation with the City; and

WHEREAS, it is fitting and appropriate to recognize elected officials upon completion of their service to the community; and

WHEREAS, recognition for these and similar accomplishments may consist of awards, certificates, plaques, keys to the City, or other similar methods deemed to be an appropriate method of recognition; and

WHEREAS, such awards, certificates, plaques, keys to the City, tokens of appreciation, etc. are not gifts but are tangible symbols of such recognition by their community; and

WHEREAS, it is appropriate for the Mayor/and or City Council to recognize individuals in the community who have made these contributions to the overall quality of life in our community;

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO DOES HEREBY RESOLVE AS FOLLOWS:

Section 1. The Mayor is authorized to procure, at public expense, fitting recognition for the above enumerated individuals who have served the City or represented the community.

Section 2. The cost should be an amount considered under law as de minimis and as allowed in the city budget.

Section 3. The presentation of these tokens of appreciation should be at an appropriate venue fitting for the award which includes meetings of the City Council.
