A RESOLUTION OF THE CITY OF POULSBO, WASHINGTON, AMENDING THE ENGINEERING DEPARTMENT APPLICATION FEE WORKSHEET TO UPDATE ENGINEERING FEES PURSUANT TO SECTION 3.12.010(B) OF THE POULSBO MUNICIPAL CODE.

WHEREAS, Poulsbo Municipal Code 3.12.010(B) authorizes changes to the fee schedules by resolution adopted by Council; and,

WHEREAS, the Engineering Department has determined that engineering fees should be adjusted to more appropriately reflect the cost of review by the Engineering Department staff; and

APPLICATION FEES

Revised by resolution 2013-10

Pre-Application Conference Fees: Apply to each pre-application conference.

Application Fees:

1. Application fees apply to the original submittal and one re-submittal. Subsequent re-submittals will require payment of hourly charges. The City Engineer may determine that the scope of the review of the original submittal and/or resubmittal requires payment of hourly charges in addition to the application fee. Fees are non-refundable.
2. Hourly charges will also be assessed for other Engineering Department services, including, but not limited to, plan review, latecomer agreement ("delayed benefit") applications, franchise applications, Master Plan review, EIS (Environmental Impact Statement) review, and special requests requiring Department staff time.
3. When hourly charges apply, the applicant will be billed at the hourly rate for actual costs incurred. The hourly rate shall be based on the annual Salary & Wage Resolution & the current budget.
4. Costs for engineering, legal, or other professional services actually incurred by the City which arise out of the processing of any land use permit application shall be reimbursed by the applicant.
5. Deposits for Engineering Department services or other professional services shall be paid in advance. Deposits may be required at the time of, or after, payment of application fees. Unused deposits are refundable.
