A RESOLUTION OF THE CITY OF POULSBO, WASHINGTON, ADOPTING A FEE SCHEDULE FOR PARK AND RECREATION FEES AND CHARGES PURSUANT TO PMC 3.12.010, 3.12.050(A) and 3.12.050(B)

WHEREAS, PMC 3.12.050(A) adopts a fee schedule for parks and recreation fees and charges processed by the City, and PMC 3.12.050(B) adopts a fee schedule for sign permits, and

WHEREAS, PMC 3.12.050 and 3.12.010 provide that the fee schedules for parks and recreation fees and charges and sign permits can be adopted and amended by the passage of a resolution by the Poulsbo City Council, and

WHEREAS, the Parks and Recreation Director has recommended that the City Council add a nonresident fee to park use application fees, and

WHEREAS, the Parks and Recreation Director has recommended that the City Council increase the sign permit fee for promoting events not located within the city of limits of Poulsbo, and

WHEREAS, the Poulsbo City Council desires to adopt the fee scheduled as provided herein, now, therefore,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Fee Schedules. The Park and Recreation Fees and Charges Schedule as set forth on Exhibit A and incorporated herein by this reference as if fully set forth is adopted by the City pursuant to PMC 3.12.050(A) and 3.12.050(B).

<u>Section 2.</u> <u>Effective Date.</u> This resolution shall take effect and be in full force upon passage by the City Council. All applications filed after the passage of this resolution shall be charged fees based on the Land Use Application Fee Schedule attached as Exhibit A.
