The City of Poulsbo's "Fee Schedule for Land Use Applications," as adopted and previously amended by City Council resolution pursuant to Sections 3.12.030(A) and 3.12.010(B) of the Poulsbo Municipal Code, is hereby further amended to revise the fees for certain applications and services to be as set forth on Exhibit A attached to this resolution and incorporated herein by this reference as if set forth in full.

<u>Section 2</u>. <u>Effective Date</u>. The amended fees established by this resolution shall become effective immediately upon passage.
