~~**WHEREAS**, Seven of the nine representative positions of the board are vacant; and~~


**WHEREAS**, the liability associated with compliance with state laws regarding public records and open public meetings outweighs the benefits of the board at this time;

Resolution No. 2012-12, passed by the City Council on August 1, 2012, is hereby repealed.


