1. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

Mayor Erickson called the meeting to order in the Council Chambers at 7:00 PM and led the Pledge of Allegiance.

2. AGENDA APPROVAL

3. COMMENTS FROM CITIZENS

Mayor Erickson asked for citizen comments; no comments were received.

4. EXECUTIVE SESSION

a. Executive Session for Real Estate Matters pursuant to RCW 42.30.110(1)(c) for 15

minutes.

Mayor Erickson recessed the meeting into executive session at 7:03pm.

At 7:18pm, Mayor Erickson extended the executive session for an additional 15 minutes.

No action was taken.

5. MAYOR'S REPORT AND COUNCIL COMMENTS

Councilmember Nystul shared a WSDOT list he received from the SR-305 Working Group with the recommended investments for the conceptual projects from Hostmark to the ferry. Senator Rolfes and the delegation were able to secure \$36MM over the next three bienniums for this stretch of the highway.

Councilmember Lord congratulated the City for the effort everyone put in at the various volunteer projects on May 5.

Councilmember McGinty attended Spirit of Giving last Thursday at the Kiana lodge with Councilmember Stern and Mayor Erickson.

Mayor Erickson attended Law Day and was a panelist talking about the separation of powers between executive, legislative, and judicial branches, and she attended the Martha and Mary Gala Saturday night.

Councilmember Thomas said he was able to attend the cemetery clean up, the Centennial Park clean up, and the mural painting on May 5. He noted the Waterfront Park looks great. The seaplane fly-in was happening that day. Kudos to Parks & Recreation and all the volunteers.

Councilmember Musgrove was bouncing all over the place this weekend and was also able to attend the Poulsbo Garden Club plant sale and the Farmers Market. The mural painting was a blast.

Councilmember Stern said the San Juan Islands cruise will begin stopping at Poulsbo again this summer.

7. BUSINESS AGENDA

a. Special Event: Marine Safety Day

Parks & Recreation Director McCluskey presented the agenda summary, noting the sponsor is the Poulsbo Police Department and First Responders, the site is Muriel Iverson Williams Waterfront Park, the date and time are Sunday, May 13, 10am-3pm, and they are expecting 200 participants. Marine Safety Day will include partners: Port of Poulsbo, Poulsbo Police Department, WA State Parks Boating Program, Poulsbo Fire Marine Program, USCG Auxiliary Flotilla, Agate Pass Sail and Power Squadron, and Safe Kids Coalition. It will also include pop up tents with marine safety displays and exhibits in the north end of the park.

Councilmember Lord said this was discussed at Community Services Committee, and they recommended approval.

Motion: Move to approve the Special Event application for Marine Safety Day as presented.

Action: Approve, Moved by Lord, Seconded by McGinty. Motion carried.

b. 2019-2020 Biennial Budget Calendar Review

Finance Director Booher reviewed the 2019-2020 Biennial Budget calendar.

Councilmember Stern said they have had some conversations about the proposed budget versus working budget and the columnar budget. They will be hearing from departments on risks and opportunities that translates into policies to give the mayor the guidance to emphasize in the budget. The policies form the basis for the budget.

Finance Director Booher clarified the three-columnar approach is still utilized in both years. The Mayor's proposed preliminary budget is the starting point, and then when they talk about additional funding they look at baseline adjustments and new program requests and modifications and the Mayor's recommendation on whether

to fund them or not fund them, and then the Finance Committee's recommendation on the requests. The three-columnar approach makes it a working budget. Staff works to give a good starting point of the base budget in working with the Mayor to lessen the workload on the Council, but still want the collaboration.

In response to Councilmember McGinty, Finance Director Booher said this process is the same process we used last time and no changes have been made.

Councilmember Musgrove said he is glad we are retaining the three-columnar approach. It is important to see what the Mayor's opinion is, it is very valuable.

c. Financial Status Report

Finance Director Booher reviewed the 1st Quarter 2018 Financial Status Report, outlining revenues, expenditures, financial policy compliance, cash & investment balance and capital project status year-to-date through March 31, 2018.

Mayor Erickson clarified the City has spent \$7,370 at the Poulsbo Library for the month of March for utilities (operational costs).

Councilmember Thomas emphasized that the treatment for the manganese in the water is complete, and that affects the east side of the City. A lot of the public are still unaware that this project was done.

Mayor Erickson said all of these are City projects; this has nothing to do with the private sector projects that are happening.

 - Increasing cultural and economic diversity will increase the need for public defender and interpreter services.

programming instead of sustaining existing successful programming. The Council could work to craft a letter with the mayor to the program or the County Commissioners to suggest effective programs can be funded on an on-going basis.

Mayor Erickson said her job is to weave all these ideas together and bring them forward in a cohesive way to the Council for them to make the determination if the policies that are implicit in what they say are what we are doing. One of the underlying themes is succession planning. The City doesn't work unless it has qualified people and people who have been trained with the institutional knowledge of the organization. There will be bumpy times in the next ten years with retirements. The knowledge transfer that occurs is crucial. She believes the City needs a Law & Justice Center in the next ten years due to the population growth. Parks & Recreation needs a new home; the building is falling apart, and the land is very valuable. The highest priority from a physical standpoint is getting the Public Works Facility built.

<u>Community Services Committee:</u> Councilmember Lord reported they discussed the Marine Safety Day Special Event, a Youth Advisory Council (possible Council goal), Street
