ORDINANCE NO. 2018-19

AN ORDINANCE OF THE CITY OF POULSBO, WASHINGTON RELATING TO THE MUNICIPAL WATER, WASTEWATER AND STORMWATER UTILITIES AND GARBAGE COLLECTION AND DISPOSAL, AMENDING POULSBO MUNICIPAL CODE CHAPTER 8.16 ENTITLED "GARBAGE COLLECTION AND DISPOSAL" AND POULSBO MUNICIPAL CODE CHAPTER 13.70 ENTITLED "ASSESSMENTS, RATES, FEES AND CHARGES" IN ORDER TO CHANGE CPI-U REFERENCES TO SEATTLE-TACOMA-BELLEVUE, PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Chapters 8.16 and 13.70 of the Poulsbo Municipal Code ("PMC") utilize an automatic rate adjustment schedule based upon the Consumer Price Index for all Urban Consumer (CPI-U) published by the Bureau of Labor Statistics, and

WHEREAS, the CPI-U service area and name was amended by the Bureau of Labor Statistics since Chapters 8.16 and 13.70 of the City Code were adopted, and

WHEREAS, there is a need to adjust the CPI-U references to accurately reflect the service area and name currently applicable to the City, NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Amendment. The following sections of PMC Chapters 8.16 entitled "Garbage Collection and Disposal" and 13.70 entitled Assessments, Rates, Fees and Charges" are hereby amended to read as set forth below:

8.16.070 CPI Adjustment

In addition to such other changes as may be approved by City Council, commencing January 1, 2010 and in January of each successive year thereafter, the fees, rates and charges in Section 3.12.090(D) shall automatically be adjusted based upon the Consumer Price Index for all Urban Consumers (CPI-U), Seattle-Tacoma-BremertonBellevue, as published by the Bureau of Labor Statistics for

the year ending June 30 of the previous year. However, these fees shall not, in any case, decrease.

13.70.180 CPI Adjustment

In addition to such other changes as may be approved by City Council, commencing January 1, 2010 and in January of each successive year thereafter, the fees, rates and charges in Section 3.12.100(A) shall automatically be adjusted based upon the Consumer Price Index for all Urban Consumers (CPI-U), Seattle-Tacoma-BremertonBellevue, as published by the Bureau of Labor Statistics for the year ending June 30 of the previous year. However, these fees shall not, in any case, decrease.

13.70.520 CPI Adjustment

In addition to such other changes as may be approved by City Council, commencing January 1, 2010 and in January of each successive year thereafter, the fees, rates and charges in Section 3.12.100(D) shall automatically be adjusted based upon the Consumer Price Index for all Urban Consumers (CPI-U), Seattle-Tacoma-BremertonBellevue, as published by the Bureau of Labor Statistics for the year ending June 30 of the previous year. However, these fees and charges shall not, in any case, decrease.

13.70.620 CPI Adjustment

In addition to such other changes as may be approved by City Council, commencing January 1, 2010 and in January of each successive year thereafter, the fees, rates and charges in Section 3.12.100(E) shall automatically be adjusted based upon the Consumer Price Index for all Urban Consumers (CPI-U), Seattle-Tacoma-BremertonBellevue, as published by the Bureau of Labor Statistics for the year ending June 30 of the previous year. However, these fees and charges shall not, in any case, decrease.

13.70.730 CPI Adjustment

In addition to such other changes as may be approved by City Council, commencing January 1, 2010 and in January of each successive year thereafter, the fees, rates and charges in Section 3.12.100(F) shall automatically be adjusted based upon the Consumer Price Index for all Urban Consumers (CPI-U), Seattle-Tacoma-BremertonBellevue, as published by the Bureau of Labor Statistics for the year

ending June 30 of the previous year. However, these fees and charges shall not, in any case, decrease.

Section 2. Severability. If any section, sentence, clause or phrase of this Ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance shall become effective five (5) days after publication of an approved summary thereof consisting of the title.
