<b>Project Description:</b>	To operate a personal training business from an existing single-family residence. The business will take place entirely within the residence.		
<b>Approval Criteria:</b>	Type II permit. The review criteria for the project include: PMC 18.70 Residential Districts, PMC 18.230 Conditional Use Permits, and PMC 19 Permit Application Procedures.		
<b>Conclusion:</b>	The PED Director, as the review authority, has concluded that the application has been found to meet the stated permit criteria, subject to the Conditions of Approval, and the project as approved will not be detrimental to the public interest, health, safety or welfare of the City.		
<b>Decision:</b>	The PED Director has APPROVED the Piety Home Occupation, subject to the Conditions of Approval found in the staff report.
