## **RESOLUTION NO. 2020-07**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, CONFIRMING AND RATIFYING EMERGENCY PROCLAMATION NO. 01-2020 AND EXTENDING THE DURATION OF EMERGENCY PROCLAMATION No. 02-2020 RELATED TO THE NOVEL CORONAVIRUS.

**WHEREAS**, Emergency Proclamation No. 01-2020 of the City of Poulsbo was issued by the Mayor on March 13, 2020, declaring a state of emergency in the City of Poulsbo as it relates to the Novel Coronavirus, also known as COVID-19; and

WHEREAS, 2.60.060 PMC provides that any emergency proclamation issued in accordance with Chapter 2.60 PMC shall terminate after forty-eight hours from the issuance, however the emergency may be extended for such additional time as determined necessary by resolution of the City Council; and

**WHEREAS**, a second Emergency Proclamation No. 02-2020 of the City of Poulsbo was issued by the Mayor on March 18, 2020, declaring a state of emergency in the City of Poulsbo as it relates to the Novel Coronavirus, also known as COVID-19; and

**WHEREAS**, the City Council desires to extend the duration of the Emergency Proclamation No. 02-2020; and

WHEREAS, the City Council desires to confirm and ratify Emergency Proclamation No. 01-2020, as well as all acts taken between March 13, 2020 and March 18, 2020 in accordance with said Proclamation;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:**


**Section 1.** The City of Poulsbo Emergency Proclamation No. 01-2020 as issued by Mayor Erickson on March 13, 2020 is hereby confirmed and ratified.

**Section 2.** All acts taken between March 13, 2020 and March 18, 2020 related to, or as a result of the City of Poulsbo Emergency Proclamation No. 01-2020 are hereby confirmed and ratified.

**Section 3.** The City of Poulsbo Emergency Proclamation No. 02-2020 shall continue in full force and effect until rescinded by action of the City Council.
