A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, DESIGNATING THE SEATTLE TIMES AS THE CITY'S OFFICIAL NEWSPAPER FOR THE TERM JUNE 1, 2020 THROUGH JULY 31, 2022.

**WHEREAS**, RCW 35A.21.230 requires the city to designate an official newspaper as provided in RCW 65.16 and the bidding laws of the State of Washington require that the official newspaper designation bids be called; and

**WHEREAS**, in accordance with state law, the bid was called for the City's official newspaper, all received packets were incomplete; and

**WHEREAS**, negotiation with the Seattle Times was recommended by the Finance/Administration Committee and reviewed by the City Council; and

**WHEREAS**, the Seattle Times in Poulsbo, Washington, is an acceptable newspaper under the regulations of RCW 65.16 and other state laws to serve as the City's official newspaper for the coming year;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF POULSBO, WASHINGTON, RESOLVES AS FOLLOWS:**

**Section 1.** The Seattle Times, which is located in Seattle, Washington and has local circulation in the City of Poulsbo, is designated as the official newspaper of the City of Poulsbo, Washington for the term of August 1, 2020 through July 31, 2022.
