- TOTES ARE NOT TO BE REMOVED FROM THE ADDRESS TO WHICH THEY ARE ASSIGNED. IF MOVING, PLEASE CONTACT THE CITY, DO NOT TRANSFER TOTES TO A NEW ADDRESS.
- IF YOU ARE OUT OF TOWN FOR AN EXTENDED PERIOD OF TIME, YOU WILL BE CHARGED FOR GARBAGE IF YOUR UTILITIES (WATER) ARE NOT TURNED OFF FIRST. CONTACT FINANCE TO TURN OFF SERVICES AT 360.394.9881

## RESIDENTIAL CLEAN UP PROGRAM

---

THE NEIGHBORHOOD CLEANUP PROGRAM IS DESIGNED TO ALLOW THE CITIZENS OF POULSBO, ON AN ANNUAL BASIS ONE FREE 1YD DUMPSTER FOR REMOVAL OF UNWANTED DEBRIS AND WASTE FROM THEIR PROPERTIES.

IT IS OFFERED; FOR A MAXIMUM OF 72 HOURS, AND DELIVERED ON MONDAY OR THURSDAYS ONLY. AVAILABILITY IS ON A FIRST COME FIRST SERVED BASIS, SUBJECT TO DRIVER AND STAFF AVAILABILITY.

CONTAINERS WILL BE INSPECTED BY PUBLIC WORKS STAFF FOR COMPLIANCE PRIOR TO ACCEPTANCE AND DISPOSAL OF SOLID WASTE. ALL TRASH MUST FIT IN THE DUMPSTER AND NOT PROTRUDE ABOVE THE LIP, ADDITIONAL CHARGES WILL BE APPLIED FOR OVERFILLED CONTAINERS.

THIS CLEANUP PROGRAM IS LIMITED TO RESIDENTIAL CUSTOMERS RECEIVING UTILITY SERVICE FROM THE CITY OF POULSBO'S SOLID WASTE UTILITY ONLY.

MULTIFAMILY AND COMMERCIAL PROPERTIES ARE NOT ELIGIBLE FOR THIS PROGRAM, AND URGED TO RENT A TEMPORARY DUMPSTER INSTEAD.

## GARBAGE

### PLEASE FOLLOW THESE GUIDELINES:

- USE ONLY TOTES PROVIDED BY THE CITY OF POULSBO
- GARBAGE IS PICKED UP EVERY WEEK, INCLUDING ALL HOLIDAYS
- TOTES MUST BE OUT FOR PICK-UP BY 7:00 AM
- ALL TRASH MUST FIT IN THE TOTE WITH THE LID CLOSED; IF YOU HAVE EXTRA, TAGS CAN BE PURCHASED AT CITY HALL
- ALL TOTES MUST BE SPACED *THREE FEET* FROM OBSTACLES; FENCES/VEHICLES/MAILBOXES
- ALL TRASH MUST BE IN TIED BAGS
- IF YOU WISH TO INCREASE OR DECREASE YOUR TOTE SIZE, CONTACT US **360.779.4078**
- EACH GARBAGE CUSTOMER IS RESPONSIBLE FOR THE TRASH RECEPTACLE(S) THAT HAVE BEEN PROVIDED

## RESIDENTIAL RECYCLING

### ONE 64 GALLON RECYCLING TOTE IS ALLOWED PER RESIDENCE

- **ONLY** RECYCLING IS ACCEPTED IN TOTES
- ALL FOOD CONTAINERS **MUST** BE RINSED OUT
- FOR AN ADDITIONAL FEE, EXTRA RECYCLE TOTES CAN BE REQUESTED BY CALLING BAINBRIDGE DISPOSAL DIRECTLY **206-842-4882**
- RECYCLING IS PICKED UP EVERY OTHER WEEK, OPPOSITE OF YARD WASTE OFFERED BY BAINBRIDGE DISPOSAL
- ALL TOTES MUST BE OUT FOR PICKUP BEFORE 7:00 AM

- PLASTIC PLANT POTS
- METAL HANGERS
- FOIL
- TOXIC CONTAINERS (MOST CLEANING PRODUCTS)

## TEMPORARY DUMPSTER RENTALS

### GUIDELINES:

- YOU MUST BE LOCATED WITHIN THE CITY LIMITS
- THE INITIAL COST INCLUDES PLACEMENT AND ONE DUMP AT REMOVAL. AFTER THE FIRST 7 DAYS, A \$10 WEEKLY RENTAL FEE WILL BE CHARGED.
- PLEASE CALL PUBLIC WORKS 24 HOURS BEFORE ADDITIONAL DUMP IS NEEDED AND FOR DUMPSTER REMOVAL. **360.779.4078**
- DUMPSTER WILL NOT BE REMOVED WITHOUT PRIOR NOTIFICATION BY CUSTOMER.
- ALL CONTAINERS WILL BE INSPECTED BY PUBLIC WORKS STAFF FOR COMPLIANCE PRIOR TO ACCEPTANCE AND DISPOSAL OF SOLID WASTE.
- ALL TRASH MUST FIT IN THE RECEPTICAL WITH THE LID CLOSED, ADDITIONAL CHARGES MAY BE APPLIED FOR OVERFILLED CONTAINERS.

### ITEMS NOT ACCEPTED...

- TOXIC OR HAZARDOUS MATERIALS— BATTERIES, MOTOR OIL
- PAINT, PETROLEUM PRODUCTS, SOLVENTS, CHEMICALS
- TIRES, APPLIANCES, COMPUTER MONITORS, TELEVISIONS
- CONCRETE, ROCKS OR SOD, LAWN MOWERS, BBQ'S
- LARGE RECYCLABLE ITEMS— METAL AND BI-METAL PRODUCTS
